

# 2011 TAMPA BAY CLASSIC BODYBUILDING & WOMEN'S FIGURE CHAMPIONSHIPS

## ENTRY FORM

- SANCTION:** This Contest is sanctioned by the National Physique Committee of the USA (NPC). SANCTION #11526
- ELIGIBILITY FOR ALL BODYBUILDING EVENTS:** Open to National Physique Committee (NPC) registered athletes residing in the Central District of Florida who must present current NPC card and driver's license as proof of residence. Over 30, 35, 40, 50, 60 competitors must have reached that age on or before June 10, 2011 and provide proof of same. Novice competitors who have placed first, second, or in an open division are not eligible for Novice competition. A competitor who has won a weight class in a Novice division may not compete again as a novice. NOTE: If you are a new or previous NPC Competitor and are unsure for which event you qualify, please call us for verification. Teenage competitors must not be over age 19 on day of show. Over all and class winners in a higher level contest are not eligible for level III classic.
- FOR WOMEN'S FIGURE & BIKINI:** Open to National Physique Committee (NPC) registered ladies residing in the state of Florida.
- ATTN: BIKINI COMPETITORS:** The bikini competitor will be judged wearing a two-piece suit preferable "off the rack" type suit. Suit must be worn at the weigh in for determination of proper fit. The bottom should be in good taste covering about 50% of the gluteal area. No thong type suits will be allowed. If the athlete has any questions they should bring a second suit with a more modest bottom. The final decision will rest with the District Chairman or his representative at the competition.
- MANDATORY CHECK-IN:** Friday, June 10, 2011, 6:30 PM to 9:30 PM at the Gaither High School Auditorium, 16200 N. Dale Mabry Hwy, Tampa, FL 33618.
- PLEASE NOTE:** ABSOLUTELY NO ENTRIES ACCEPTED AFTER FRIDAY JUNE 10, 2011 9:30 P.M. No Reweighing of registered contestants after check-in closes Friday, June 10, 2011, 9:30 p.m..
- FIGURE & BIKINI:** All figure and bikini competitors must check-in Friday night. **ATTENTION!** A meeting will be held at approximately 8:30 p.m. at the auditorium. Our own Women's Figure Pro Amy Stephens is our Figure Advisor, Shannon Dey NPC Figure Chairperson and Jamie Baird Pro Bikini Champion, will assist at the meeting. The show director will conduct the meeting.
- TICKETS:** Tickets can be purchased at Friday check-in, cash only .
- NPC CARD:** If you don't have an NPC card, one can be purchased at check-in (check ok).
- IMPORTANT:** Please bring with you: (1) NPC Card (2) Drivers License (3) Music CD-R. No factory recorded CD's will be accepted, only burned CD-R's. Your CD should have only one song on it. (Posing time 60 seconds). \*PLEASE NOTE: Do not use a song with profanity or vulgar lyrics or you will be disqualified from the competition. The head judge will make this call. - VIDEO & CAMERAS:** Our show as always will be exclusively videotaped by USA Muscle. No other video camera will be allowed. Please order your tape at show (deliveries approximately 4 weeks after show). No Professional Photography will be allowed at day or night shows unless sanctioned by promoter.
